

Importance of having a vibrant Main Street

The MoTI-funded removal of the Hwy 97 couplet and the transfer of Main Street back to City of West Kelowna.

Recommendation #1 - <u>Transportation Impact Assessment</u> (TIA) of the Highway Couplet regarding the realignment and transfer of Main Street to City authority?

Results: A TIA has not been undertaken. (Source: Allen Fillion, Director of Engineering)

Recommendation #3 - <u>Memorandum of Understanding</u> (MoU) with MoTI to confirm, commit to and fund the preferred concept for removal of the couplet through Westbank Centre based on the technical analysis and recommendations of the plan, namely, to remove the Provincial highway function from Main Street and implement the preferred concept for Dobbin Road to accommodate all Provincial highway functions through the town centre.

Results: "I am unaware of any such MOU." (Paul Gipps, CAO)



Recommendation #3 - Westbank Parking Study.

Results: Yes, the city has reviewed parking requirements in Westbank Centre in the last 15 years. The city is currently undertaking a review of parking to help implement changes associated with the new Official Community Plan. We anticipate the review and corresponding report to Council to happen shortly. (Source: Chris Oliver, Planning Manager)

Recommendation #4 - <u>Business Case Analysis</u> for Westbank Town Centre business regarding realignment and transfer of Main Street to City authority.

Recommendation #5 - Sidewalk Café Policy.

Recommendation #6 - Street Tree Policy.

Resurrected - revive the practice, use, or memory of (something); bring new vigor to.







A pedestrian-orientated Main Street connecting city businesses, services and amenities.



Objective #4:

Current: To have Brown Road develop into a high street, thereby being the most prominent area for a mix of activities with street fronting commercial uses.

Amended: To have Main Street restored into a high street, thereby being the most prominent area for a mix of activities with street fronting commercial uses.



Why?

Main Street is an identifiable entrance or welcome corridor to Westbank Town Centre for residents and visitors alike.

Main Street, the centre of Westbank, should be our street NOT the provinces.
